AAUA Individual Membership Categories

Sponsoring Member (annual dues: \$250) – Open to any person interested in the administration of higher education. A Sponsoring Member receives full membership benefits, can vote on Association business at the national level, and through this category, provides support for AAUA initiatives in addition to receiving a premier listing in the AAUA Membership Directory. *Annual Dues: \$250*

Sustaining Member (annual dues: \$150) – Open to any person interested in the administration of higher education. A *Sustaining Member* receives full membership benefits, can vote on Association business at the national level, and—through this category—provides support for AAUA initiatives in addition to receiving a premier listing in the AAUA Membership Directory.

Active Member (annual dues: \$100) – Open to any person interested in the administration of higher education. An *Active Member* receives full membership benefits, can vote on Association business at the national level.

Emeritus Member (annual dues: \$55) – Open to any former member who has retired from his/her institution. An Emeritus Member receives all membership benefits, except a vote at the national level.

Student Member (annual dues: \$35) – Open to any graduate student enrolled in an institution of higher education who is interested in the field of higher education administration. A Student Member receives all membership benefits, except a vote at the national level.
